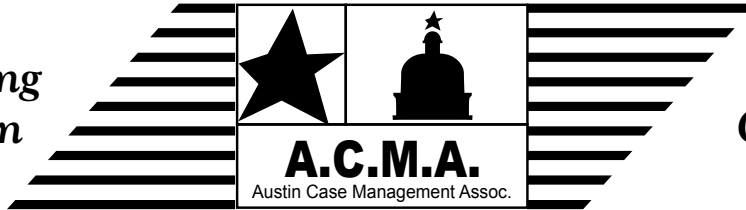

Our speaker, **Dr. McCarty**, will be speaking on "An Indepth Look at Stroke and Stroke Prevention"

Dr. McCarty received his medical education and internship from the University of Oklahoma. He completed his anesthesia residency at the University of Texas Health Science Center in San Antonio. He spent 13 years in Tyler, Texas, furthering his career as an anesthesiologist and gaining skill in acute and chronic pain medicine. There, he chartered and developed what is now one of the largest practices in the state. After completing an Interventional Pain Medicine fellowship at the University of South Florida in Tampa, he joined Austin Pain Associates. He is an active member of the International Spinal Injection Society and the American Society of Interventional Pain Physicians.

He assisted in the development of the Stroke Programs at Brackenridge and Seton Medical Centers, which were awarded primary stroke designation status by JCAHO (the first in the state of Texas). He is an assistant Professor and Director for the UTMB Neurology Residency Program.

Darryl Camp, M.D. is the Medical Director of Neurology for the Seton Network and is a Diplomat of the American Board of Psychiatry and Neurology.

Dr. Camp has won numerous awards, is involved in several research studies and has published several articles including Stroke Prevention in Atrial Fibrillation and Infrared Transmission of Bovine Ocular Media.
