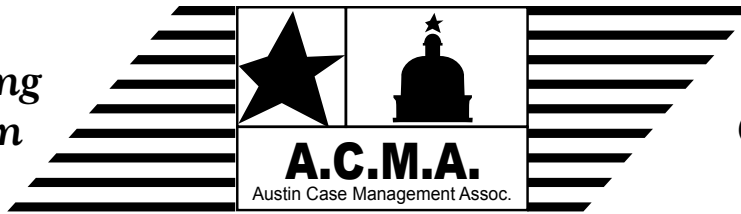

Our topic this month is "The Neuropsychological Consequences of Substance Abuse" presented by Kent H. Foster, PhD., Neuropsychologist. The seminar will focus upon the brain structure and functioning as a result of alcohol and substance abuse. There will be a review of four functional systems within the brain, the elements of cognition, and the relationship between cognition and brain functioning. The elements of addiction, opponent process, tolerance, withdrawal, and relapse will be discussed. The reasons that individuals use and abuse drugs, as well as the negative consequences will be discussed, for alcohol, marijuana, cocaine, amphetamine and ecstasy. Audience participation will be encouraged throughout the presentation, and handouts will be provided

ArrangeCare, a private case management practice in Austin has a contract opening for a currently licensed RN, preferably Spanish speaking. The person will have the opportunity to work with a wonderful team comprising two experienced social workers, a benefits specialist, a bookkeeper, a case aide, and an office manager. Malpractice coverage is provided. Expected contract rate is \$30/hr, which includes travel time but not mileage.
