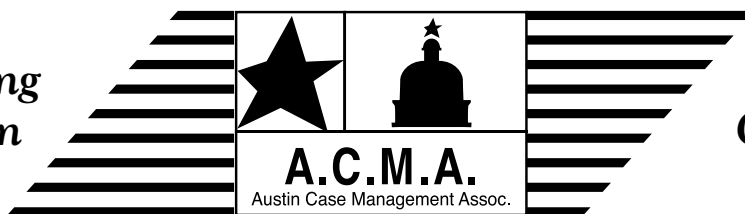

Acadian Ambulance provides emergency and non-emergency service to Travis, Williamson and Hays counties, is the 911 provider for Bexar County and serves six counties in Southeast Texas.

Acadian has recently joined forces with Central Texas EMS to bring high quality ambulance and medical transport services to the region. With this acquisition, Acadian's operation will be the largest in Central Texas with 15 stations, 350 employees and 70 ambulances. Acadian Ambulance of Central Texas will provide service in Falls, McLennan and Bell counties in addition to the areas already served by Acadian.

Acadian offers a bariatric ambulance with a 1,200-pound capacity, Critical Care Transport units with Multi-Med pumps and ventilators including BiPAP and pressure-support, dialysis transports and event standbys. The Acadian Transport Assistance Center provides 24/7 insurance information and determination of medical necessity from a non-emergency transport specialist.

Established in 1971, Acadian has about 3,600 employees and is nationally accredited, one of only 122 ambulance services in the nation and one of six in Texas to have earned the prestigious designation.

Our topic this month is "**The Impact of Healthcare Reform on Medicare.**" With the Healthcare Reforms passed in 2010, there were significant changes to the Medicare program effective immediately, with more proposed changes over the next nine years. Some changes are very specific; many others have a more generic focus or are long-term goals to improve health delivery systems. This session will review the most important provisions affecting nearly all of the 48 million Americans currently covered under Medicare parts A, B, C and D. Because Accountable Aging Care Management makes national policy changes like these a focus in the comprehensive elder care consulting services they offer, they are very familiar with the affects of the reforms. This session will go over the changes to the new preventive care benefits, the effect on the prescription drug "donut hole" and many other less known changes that everyone involved in elder care and consulting needs to be aware of going forward.
